



As part of Chinook Gate’s master-planned community, Brookfield Residential incorporated the Chinook Gate Homeowners Association, which is responsible for the (future) enhanced maintenance of certain public greenspaces within the community. These enhancements complement Chinook Gate’s overall development concept and clearly distinguish Chinook Gate from other communities.

Annual fees are not optional to ensure sustainability and to cover operating and maintenance costs of the Association, including the Chinook Gate enhancement program. Each property will be subject to an annual charge evidenced in the form of an Encumbrance registered on title, securing payment to the Association. The maximum amount of such Encumbrance payment for each lot and unit is \$150.00 per year, plus an adjustment by percentage increase, if any, of the “All Items” Consumer Price Index (CPI), plus GST, as per the Encumbrance and Articles of Association. The annual payment for 2026/27 is \$107.00 plus GST.
